Terms of Service and Release of Liability

By agreeing to speak at the National Healthcare Coalition Preparedness Conference (NHCCPC) being held at the Rosen Shingle Creek in Orlando, FL on December 10 - 12, 2024 (Event), and for and in consideration of NHCCPC allowing me to participate (as a speaker) at the Event, I, for myself, and on behalf of my spouse, children, guardians, heirs and next of kin, and any legal personal representatives, executors, administrators, successors and assigns, hereby agree to release, waive, covenant not to sue, assume all risk of transportation, attendance or participation in any or all activities of the Event, and further agree to indemnify, defend and hold harmless NHCCPC, its employees, officers, directors, administrators, agents, instructors, speakers, members, other participants, sponsoring agencies, hosting hotel/conference hotels/venue – all of which are hereinafter referred to as Released Parties, from any and all liability for any and all claims (including, but not limited to, third party claims arising from or in connection with a violation of NHCCPC policies), judgments, costs including attorney's fees, demands, losses, or damages on account of injury, death or damage to property, caused or alleged to be caused by even the negligence of Released Parties, incurred in connection with any action brought in any way connected with the Event. This agreement is specifically intended to operate as a waiver of liability to the fullest extent allowed by law. I hereby acknowledge that I have read and agree to be bound by the terms of this Release.

Force Majeure – The performance of this Letter of Agreement is subject to acts of God, war, government regulations, domestic terrorism, disaster, strikes, civil disorder, curtailment of transportation facilities, pandemic or health emergency, or any emergency beyond the parties' control, making it impossible to perform either party's obligations under this Agreement. In addition to the above, it will be considered a Force Majeure event under this Letter of Agreement if, within ninety days in advance of the scheduled event, a regulatory agency promulgates an ordinance, law, or restriction that prohibits the holding of the event. If the state or local government with jurisdiction over the event location issues (or maintains) a restriction effective for the date(s) of the scheduled event limiting the number of attendees at an event to a number that would make the scheduled event impossible, or if within ninety days in advance of the scheduled event, the event venue is closed due to Covid-19 infection or other health emergency. In the case of Force Majeure, the non-performing party may terminate this Agreement, without liability, upon written notification. In the event of an unavoidable emergency (physical incapacitation, sickness, weather, etc.) that leads to speaker having to cancel, speaking fees will be waived and a full refund issued for any amount already paid.

The relationship of the parties hereto and all claims arising out of or related to that relationship, including, but not limited to, the construction and interpretation of this agreement, will be governed by the substantive laws of the State of Indiana. NHCCPC principal office is in the State of Indiana, United States of America. By being a speaker at this conference, NHCCPC and I agree that the statutes and laws of the State of Indiana, without regard to conflicts of laws principles thereof, will apply to all matters relating to any injury which may occur to me in connection with the Event. In the case of a dispute, NHCCPC and I agree any litigation arising between the parties hereto shall be brought only in the state or federal courts having subject matter jurisdiction in Indiana. I hereby irrevocably and unconditionally consent to the jurisdiction of any such court and hereby irrevocably and unconditionally waive any defense of an inconvenient forum to the maintenance of any action or proceeding in any such court, any objection to venue with respect to any such action or proceeding, and any right of jurisdiction on account of the place of residence or domicile of any party thereto.

I consent to receive communications from NHCCPC by e-mail. I agree that all agreements, notices, disclosures and other communications provided by NHCCPC satisfy any legal requirement that such communications be in writing.

I also agree not to allow any other individual to speak at the conference in my place without approval by NHCPC prior to the Event. I consent to NHCPC using any photos, other images taken of me, and any results of conference related activities that occurred during the conference for media outreach efforts, promotional campaigns, various publications/communications, or other business purposes as determined by NHCPC.
